Abstract

Merger control relies on costly evidence provision to screen submitted merger projects. We model the enforcement of merger policy as a confrontation of evidence between the agency and the merging firms, and examine the opportunity of a tougher stand against mergers. We show that a stricter merger enforcement can increase the probability to block anticompetitive mergers but also impact the evidence production. This may undermine the effectiveness of merger control.

- [3] **Litigation and the Informational Value of Precedent: An Application to Antitrust Commitments**, with Andreea Cosnita-Langlais.

Abstract

This paper examines the impact of commitment decisions on the efficiency of antitrust enforcement. We discuss the optimal use of commitments by focusing on the role of precedent produced through formal litigation. Our framework allows to combine key effects in the same model: the deterrence of the primary behavior by the different procedural instruments (commitments or formal prohibitions), and the dynamic perspective through the focus on precedent production through trial. We show that if the level of penalty is high enough, the antitrust authorities undervalue the dynamic benefit of legal precedent and tend to over-use commitments.

- [2] **Merger selection, evidence provision and the timing of merger control**, with Andreea Cosnita-Langlais.

Abstract

Merger control impacts the type of merger projects that are submitted, as well as the information provided by the merging parties upon assessment. In this paper we consider the outcomes in terms of selection of types and evidence provision of alternative timings for the merger assessment, pre- or post-consummation of the merger. We show that the selection effect induced by the ex post merger control is welfare-improving, through the deterrence of the most anti-competitive projects. In contrast, the welfare impact of evidence provision under ex post merger control is ambiguous. Balancing these two effects makes possible the welfare comparison between the ex ante and the ex post enforcement.

- [1] **How to design the control of mergers in the digital industry? A theoretical approach.**

Abstract

In the present paper we develop a simple model to address the question of the efficient design of the control of mergers between main digital platforms and smaller innovative firms. We examine the role of both the burden of proof and the standard of proof on the efficiency of the merger control when the firms decide to merge but also on the incentive to innovate. We suggest that a burden of proof on the merging firms combined with a low standard of proof is the most efficient merger control design except if the investment cost is high.
